2017 Dash 4 Cash

(Only Chapters assigned to the NY District can compete in the Dash for Cash Program)

New York District GWRRRA “Dash 4 Cash” has entered its tenth year – its purpose is to encourage Chapters to visit each other, to participate in GWRRRA programs, and to attend rallies and other functions within the District, Region and beyond.

The New York District will pay \$50 towards the charter fee for calendar year 2018 for any chapter meeting the qualifications and earning 25 points. Points may be earned from January 1, 2017 through November 30, 2017. The chapter with the most points in excess of 25 at the end of the program period will also be awarded a check for \$100.00.

New York District 2017 Dash 4 Cash Rules & Definitions

(Only Chapters assigned to the NY District can compete in the Dash for Cash Program)

A. Rules:

- a. A minimum of 5 card-carrying GWRRA Members must attend an event or gathering to qualify for attendance points.
- b. Each participating chapter must visit at least one Chapter Gathering and attend one chapter event to qualify for the program. (See Definitions 1 and 2)
- c. Each chapter can earn a maximum of 6 points from visiting any one chapter
- d. Mileage points can only be awarded for attending a chapter gathering or event. (See Definitions 1 and 2)
- e. Hosting a District Event must be approved in advance of the event and will be at the discretion of the District Director.
- f. The New York District Directors are not eligible to be counted in a chapter's 5 card-carrying members. The remainder of the New York District staff is eligible to be counted and are expected to participate in the program to the fullest extent possible.
- g. All entries shall be submitted as a complete Dash 4 Cash package and emailed to ADD Ted and Janice Zamorski (gwrra.westny.add@gmail.com) and shall include "D4C" and the chapter name in the subject line i.e., D4C Chapter NY-Y
- h. All entries must be received within 15 days of the event for which submitted.

D. Definitions:

1. A chapter Meeting/Gathering is defined as a regularly scheduled monthly meeting as published in the Chapter newsletter or on the District or Chapter website.
2. A chapter Event is defined as any chapter event (including a ride) other than a gathering that is open to all chapters.
3. A chapter assisting with NY/NJ Bi-State Rally is defined as a Chapter signing up for and carrying out a task as approved by District Director.
4. For Traveling Plaque and chapter visitation/event points, all distances are the shortest Google Map distances between traveling Chapter's Gathering Place displayed on District web page and relinquishing chapter's gathering place displayed on District web page or advertised event location (nearest town/city). Points are awarded only for full compliance with Traveling Plaque rules, posted on the District web page.

E. Disclaimers and Legal Stuff:

1. A complete Dash 4 Cash package is defined as the official submission form (provided on the District webpage) with photo showing all 5 (or more) visiting chapter members and the GWRRA Officer of the host chapter, with the rest of the form filled in as listed.
2. An acknowledgement will go to the sender once the submittal is received. If you do not receive acknowledgement, contact ADD Ted and Janice Zamorski.
3. Any and all disputes, ties and discrepancies will be sent to ADD Ted and Janice Zamorski who will forward them to the New York District Director for a determination.
4. The NY District Director reserves the sole right to modify, suspend, or discontinue the program for any reason at any time.

Mileage points will be awarded as follows:

1 to 100 mi 1 pt
101 to 200 mi 2 pts
201 to 300 mi 3 pts
Greater than 300 mi 4 pts

NOTE: Chapter members that seasonally reside outside New York during winter and attend a chapter's gathering or event, in the state they are seasonally residing in, will be allowed to claim mileage points from a location that is centered on their seasonal residences to the location of the out of state's gathering or event location. The central location of their residences must be included in the request.
